## **DOCUMENTS FOR NEW REGISTRATION (Italian citizens)**

In order to complete 2022/23 season registration, at least one parent needs to be inside the office together with the player and these documents (for those who are Italian citizens)

- Certification of Employment and family members released by the Municipality
- A valid sports fitness physical. It should be “*agonistica*” for children over 12 years and “*non agonistica*” (done by the pediatrician or your own doctor) for children under 12 years.
- Passport photo of the player
- Tax code of the player

## **DOCUMENTS FOR NEW REGISTRATION (non Italian citizens)**

For those who are not Italian citizens, these are the documents we need:

- Certification of Employment and family members released by the Municipality or Air Base (look at the next page for an example)
- Residence permit for the player and the parents (if he is a non-EU citizen)
- A valid sports fitness physical. It should be “*agonistica*” for children over 12 years and “*non agonistica*” (done by the pediatrician or your own doctor) for children under 12 years.
- Player's Identity card / Player's passport
- Parents' Identity Card / Parents' passport
- Passport photo of the player
- Declaration in which you say that the player has never been registered abroad (we'll give you the document while doing the registration)
- Certificate of school attendance

## **DOCUMENTS TO RENEW REGISTRATION**

For those who wants to renew registration:

- Passport photo of the player (only if the player is going to change from Primi Calci to Pulcini)
- A valid sports fitness physical. It should be “*agonistica*” for children over 12 years and “*non agonistica*” (done by the pediatrician or your own doctor) for children under 12 years.
